PUBLIC INQUIRIES INTO THE PROPOSALS BY THE BOUNDARY COMMISSION FOR WALES FOR CONSTITUENCY BOUNDARIES IN WALES

Inquiries are to be held on behalf of the Boundary Commission for Wales into their provisional recommendations for constituency boundaries in the preserved counties of Gwent/Mid Glamorgan, Clwyd/Gwynedd, South Glamorgan and West Glamorgan. The Commission published their proposals on 5 January 2004, recommending that adjustments be made to 23 of the existing 40 seats, to reflect changes to preserved counties and local government areas and to reduce the disparity in the electorates.

Objections made about these proposals in the Preserved Counties of Clwyd/Gwynedd, Gwent/Mid Glamorgan, South Glamorgan and West Glamorgan have required the holding of a local inquiry under the Parliamentary Constituencies Act 1986. Official notice of the inquiries will be published in local newspapers during the week commencing 17 May 2004.

Each inquiry will be held in public and any interested person, whether a supporter of or objector to the Commission's proposals, may attend and be heard. The Commission would urge all interested parties to attend and make their views known. It should not be assumed that the inquiry will only discuss those matters raised in representations submitted during the representation period allowed nor that the Commission's provisional recommendations will remain unchanged. On many occasions, following consideration of the evidence submitted at the inquiry and the Assistant Commissioner's report, the Commission have revised their recommendations. While the Commission will always invite written representations against any revised recommendations they might publish, all interested parties should be aware that they may not be able to state their case at a further inquiry, as a further inquiry will only rarely be held.

Details of the inquiries in each area are as follows:

CLWYD/GWYNEDD

The inquiry will be held by the Assistant Commissioner, Mr David Lloyd Jones QC. It will open on:

6th July 2004 at 10.00am in the Powis Hall, Main Arts Building, University of Wales Bangor, College Road, Bangor LL57 2DG, and 8th July 2004 at 10.00am in the Council Chamber of Denbighshire County Council, Council Offices, Wynnstay Road, Ruthin LL15 1YN.

In the preserved county of Clwyd, the main objection to the provisional recommendations is in respect of the names of the proposed constituencies, particularly the Conwy constituency.

In the preserved county of Gwynedd, the main objection to the provisional recommendations is in respect of the proposed constituencies of Arfon and Dwyfor Meirionnydd. Most of the objections suggest that the existing arrangements should remain. A smaller number of representations have suggested that the Bangor area be included within the existing Caernarfon constituency. Objections have also been made in respect of the proposed consequential change to the North Wales and Mid and West Wales Assembly regions. A number of representations have also suggested that the Commission should await the publication of the report of the Richard Commission.

Richard Commission

The Richard Commission was established by the National Assembly for Wales in July 2002 and was asked to consider whether the size of the Assembly is adequate to its present job; whether the present electoral system is sufficiently representative; and whether any changes would be needed if the Assembly were to acquire further powers. The Boundary Commission for Wales has, in the course of carrying out its current general review of Parliamentary constituency boundaries in Wales, received a number of representations, in reply to the Boundary Commission's provisional recommendations, to the effect that the Boundary Commission should defer making its Report to the Secretary of State until the Richard Commission has reported. The Boundary Commission have carefully considered these representations, together with the Report of the Richard Commission which has now been published, but have decided that they do not justify any alteration to the timetable of the present Review. The Boundary Commission will, however, draw the representations to the attention of the Secretary of State in submitting their final recommendations.
