Please see enclosed a petition that was signed between November 2021 and January 2022 and contains **628** residents and business signatures regarding the splitting of the Cynon Valley into two other constituencies.

The Cynon Valley Labour Party intended that this petition would continue during consultations but due to ongoing covid effects, road works, road closures, by-elections, cancelled meetings, work connected to realignment of Senedd boundaries, the MP's cost of living petition, Ukraine and the weather meeting the public had to be curtailed.

However I am of the opinion that if these boundary changes had been delayed until the UK and indeed Wales had been given more time to recover from the above the petition would have reached at least 75% of the valley population.
